A MOTION was made by Roderick Hillis and seconded by Rudy Stripp to approve the minutes of the previous meeting. ALL AYE votes cast, MOTION carried.

A MOTION was made by Daniel Deysenroth and seconded by Roderick Hillis to approve the Supervisor's monthly report. ALL AYE votes cast, MOTION carried.

- Have been using a lot of sand due to the snow storms.
- With most of the recent snow storms occurring on the weekends, many overtime hours have been worked.
- Have been trying to keep up with maintenance on vehicles between storms.
- The Sterling front king pin and steering knuckle is on the truck and working fine.
- Have one more load of salt to order for the Village of Hobart.
- According to NYMIR the fire claim for the Oshkosh truck fire has been settled and I am waiting to confirm if the Town can buy back the burnt Oshkosh.
- Will be putting up more road signs and looking over road surfaces when the weather improves.

Discussed was the South Kortright Sewer System preconstruction meeting that was held yesterday.

Supv. Triolo informed the board grants for the South Kortright playground will be applied for through Senator Seward's office, the O' Connor Foundation and another possibly through the Southern Tier in Binghamton.

Annual physicals for the highway workers was further discussed. The town will pay for the physical if the insured has already applied for the one covered wellness visit allowed a year.
