- Received a grant approval from the Delaware Co. Soil and Water Conservation District to replace culvert pipes on Roxbury Mountain Rd. and Narrow Notch Rd.
- Will prepare bid specifications for replacing a portion of the old garage roof and windows

Decker Rd. concerns were discussed and will be graded and graveled soon.

A special thank you to Ken Grant for cementing the flag pole.

Supv. Triolo replaced the basketball nets at the South Kortright playground.

Supv. Triolo will meet with a local group that is interested in holding a Farmer's Market on town grounds.

Hwy. Supt. Rice will contact the Village of Hobart to make arrangements for redwood shavings to be placed on the town office grounds.

Supv. Triolo informed the board the highway worker's union contract is to expire on Dec. 31, 2010. Arrangements will be made to start negotiations.

A Comprehensive Monitoring Report was received from the NYS Office of Community Renewal. Supv. Triolo will address the concerns and recommendations.

John Wright informed the board Invenergy is in the final stages of the SEQRA process for the wind project.
